TERMS AND CONDITIONS

I, the authorised signatory:

1. ensure that all information given in this registration form is correct.
2. undertake to give written notice to *Mrs Carike Jordaan / Prolific Maths* within seven (7) days of any changes to personal details and information as given in this agreement.
3. ensure that the registered learner will be present for all scheduled lessons, unless communicated otherwise in writing and in a timely manner, lest the contract be terminated by *Mrs Carike Jordaan / Prolific Maths*, and all overdue amounts be claimed.
4. understand that the registered learner's absence from a class, without written notice to *Mrs Carike Jordaan / Prolific Maths*, will not be justified by ignorance or negligence, and all fees will remain due and payable.
5. authorise *Mrs Carike Jordaan / Prolific Maths* to use material containing or produced by the registered learner (including but not limited to photographs, videos, testimonies, and test results) for commercial and marketing purposes.
6. undertake to ensure that I always have adequate funds available to cover the amounts due monthly in terms of this agreement.
